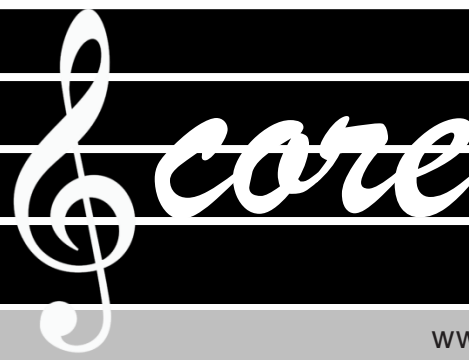

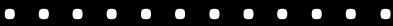

Dear TSL Members,

The Toledo Symphony League ended our fiscal year in May by rounding up our \$20,000 pledge to The Toledo symphony Orchestra to \$42,000. The money was raised over the period of one fiscal year and presented to **Randi Dier** who represented **Kathy Carroll** at our Closing Luncheon. This, added to our Scholarship Awards to young artists and our Summer Grants to TSO musicians, brings us to over \$54,000. In addition, the income generated from our Joshua Bell Pre-Concert Dinner at the Toledo Club, the underwriting of the Musicians Survival Bags presented to musicians at the Christmas Peristyle concert and our countless hours of volunteerism brings our total to well over \$60,000. Congratulations, Ladies of the League. You made it happen. We fulfilled our mission in every way.

In appreciation, **Merwin Siu**, of the Toledo Symphony Orchestra, played a breathtaking musical thank you to the women of The Toledo Symphony League at our Closing Luncheon. His violin, as always, was a bit of magic in his hands.

The ELECTRONIC SCORE, under the chairmanship of **Ann Randolph**, went smoothly, saving the League approximately \$200 each month that it was digitally mailed. In addition, it, along with our wonderful Chimers, proved to be an efficient way to disseminate updates to the membership.

To maintain our momentum, there are two changes to the President's Committee. **Patti Etue Stephens** has graciously accepted the position of TSL/TSO Special Events Liaison. Her responsibilities include organizing some post-concert receptions and fulfilling special requests made by the TSO when possible. **Lynda Gilbert** has graciously accepted the position of Nominating Chair.

Your TSL Executive Committee has been busily creating and executing planned events for another outstanding League year. “Sights and Savories on the Sandpiper” has been postponed because of rain, rain, rain. **Summer Update by Rusty Phlegar**

As members of the Toledo Symphony League, it is important that our focus be centered on our very own Toledo Symphony Orchestra and the support we can extend. Equally important, is our effort to consider what the League of American Orchestras is accomplishing on the national level. The NEA and the League of American Orchestras are the watchdogs of many issues that could impact all orchestras, in addition to relationships with foreign orchestras and artists. There are a variety of issues, both positive and negative, of which you should be aware.

**Visa Processing**

In June, the U.S. State Department experienced a computer hardware failure, resulting in a halting of visa issuances to travelers. Repairs are being made, and visas are currently being issued at about 2/3 capacity. U.S. arts organizations need to have a back-up plan to insure that international artists will be able to work in the U.S. with fully-processed visas.

**Charitable Giving**

The Charitable Rollover provision, originally enacted as part of the Pension Reform Act of 2006, permits donors aged 70½ years and older to make tax-free charitable gifts directly from their IRA's, up to an annual ceiling of \$100,000. Without the IRA Rollover Provision, individuals who make charitable gifts from their retirement accounts must treat those monies as taxable incomes, thus reducing the amount available to charity. The provision has come and gone many times; it was most recently reinstated on Dec.31, 2014. Currently, charitable giving rose to 5.4% (\$358 billion) which equals the amount achieved in 2007, just before the recession started to affect donation figures. It is imperative that the National League aim to make the Rollover Provision permanent so that donors are able to maximize the support for charitable work.

**Support FY16 NEA Funding**

The National Endowment for the Arts has held steady at \$146 million for the last four years. The NEA is asking Congress for \$155 million for FY16. Grants awarded to orchestras by the NEA provide critical funding projects that increase access to music in communities nationwide. The NEA is a critical component in the network of public, private, corporate and philanthropic support that makes America's orchestras possible. Every congressional district receives an NEA grant, which provides prosperity and enrichment to communities.

**Musical Instruments**

In the last year, there has been much controversy over musical instruments that contain even small amounts of ivory. Imagine: If your instrument contained as little as 0.2 of a gram of ivory, legally obtained, that could be confiscated even though you had obtained an instrument passport from the U.S. Fish and Wildlife Service. Two years ago, President Obama signed an executive order to eliminate wildlife trafficking, and thus instruments containing African ivory were not allowed to enter the U.S.A. if the instrument had been purchased after February, 1976. Currently, drafts of new rules regarding instrument international travel have emerged that will alter that previous executive order. The drafts are lengthy and the national league is analyzing the proposed rules for a complete understanding of their full impact.

We will do well to remember that the work of the League of American Orchestras is both important and comprehensive. Without their advocacy, many decisions by government would limit cultural exchange as well the support and opportunities they provide to our communities.

## TOLEDO SYMPHONY YOUTH ORCHESTRAS

### Dorothy Coats, Youth Orchestras Manager

New faces and rehearsal music highlight the beginning of the Toledo Symphony Youth Orchestras 2015 – 2016 season. **Patrick Barrett** and **Dr. Elaine Colprit** have been named to lead the Symphonic and Concert Orchestras. **Wasim Hawary** will be Artistic Director of the orchestras and Conductor of the Philharmonic Orchestra.

**Mr. Hawary**, the new Orchestra Director at Maumee City Schools and a graduate of BGSU, has been with the TSYO since 2000 and will continue to offer his special expertise and experience to the orchestras.

**Mr. Barrett** is a graduate of Ohio State University where he studied with Robert Gillespie, a renowned young orchestra pedagogy professor. He teaches orchestra at Perrysburg Junior High School and is very active in the music community. **Dr. Colprit** is Chair of Music Education at BGSU and teaches both graduate and undergraduate level methods courses at the University. She brings a wealth of knowledge and experience to the TSYO. In addition to these staff changes, approximately 65 new student musicians will join 130 current TSYO members for the first time.

All of this newness includes rehearsal spaces in Perrysburg Junior High School at 550 E. South Boundary St. where rehearsals will begin on September 14. Still the same will be weekly work with the TSYO staff, sectionals with Toledo Symphony members and a Side by Side Concert with the TSO. There will also be opportunities for orchestra members to audition for solo spots at orchestra concert programs and complimentary tickets for some TSO concerts remain part of the orchestra membership package.
